PREAMBLE:-

In the reference 1st cited, the Kovai Medical Centre Research and Educational Trust, Coimbatore has obtained Government Order from Health and Family Welfare (ME.II) Department, Tamil Nadu to start B.Pharm. Degree Course at KMCH College of Pharmacy, Coimbatore with an annual intake of 50 seats from the academic year 1993 - 1994.

2. In the reference 2nd cited, the university had granted the Provisional Affiliation order to KMCH College of Pharmacy, Kovai Estate, Kalapatti Road, Coimbatore -641048 for starting the B.Pharm Degree Course with an annual intake of 50 seats from the Academic Year 1995 -1996.

3. In the reference 3rd cited, the university had granted Permission for increase in annual intake from 50 to 60 seats in B.Pharmacy Degree course to KMCH College of Pharmacy, Coimbatore from the academic year 2005 -2006.

4. In the reference 4th cited, the Kovai Medical Centre Research and Educational Trust, Coimbatore has obtained Government Order from Health and Family Welfare (PME-2) Department, Tamil Nadu to enhance the B.Pharm. Degree Course from 60 to 100 seats from the academic year 2019-2020 at KMCH College of Pharmacy, Coimbatore.

9. The seats available in B.Pharm./M.Pharm./Pharm.D/Pharm.D(PB) courses shall be filled as per the orders in force. The Management shall follow a transparent and reasonable method of admission for the management quota as per orders in force.

10. The admission procedure of the Government as per the scheme of admission enunciated by the Supreme Court of India should be followed.

11. The admission procedure as laid down in the G.O. of Health and Family Welfare Department, Chennai should be followed strictly. Any admission made over and above will not be permissible on any account.

12. The approval from relevant Council should be produced every year to consider further Continuance of Provisional Affiliation.

13. Any other condition which the University considers necessary to impose from time to time should be followed strictly.
