ORDER:

In the reference 1st cited, the University granted Provisional Affiliation order to KMCH College of Pharmacy, Kovai Estate, Kalapatti Road, Coimbatore – 641 048, for Starting M.Pharmacy Degree Course from the Academic Year 2003-2004.

- 2. In the reference 2nd cited, the University had granted Provisional Affiliation order to KMCH College of Pharmacy, Coimbatore for starting New Branch Pharmaceutical Analysis in M.Pharmacy course with an annual intake of 8 seats from the Academic Year 2004-2005, subsequently increase in annual intake of 18 seats had been granted to M.Pharm. Pharmaceutical Analysis branch from the academic year 2010-2011 vide ref. 3Rd cited.
- 3. In the reference 4th cited, Continuance of provisional Affiliation had been granted to KMCH College of Pharmacy, Coimbatore for conducting M.Pharmacy course for the academic year 2019-2020.
- 4. Based on the intake approved by AICTE and PCI, which ever is less among them the University grants annual intake to B.Pharm./M.Pharm. Courses. Accordingly upto the academic year 2019-2020, 09 seats had been granted to KMCH College of Pharmacy, Coimbatore for M.Pharm. Pharm. Analysis branch.

- 5. In the reference 5th cited, the Governing Council has approved to grant CPA to M.Pharm. Course to the said institution for the academic year 2020-2021 for the existing branches/seats.
- 6. In the reference 6th cited, the Managing Trustee, KMCH College of Pharmacy, Coimbator has requested to increase the intake from 09-15 seats in M.Pharm.- Pharmaceutical Analysis Branch for the Academic year 2020-2021, along with the approval granted by the Pharmacy Council of India, New Delhi.
- 7. In the reference 7th cited, the Pharmacy Council of India, New Delhi (PCI) has granted 15 seats in M.Pharm.- Pharmaceutical Analysis Branch to KMCH College of Pharmacy, Coimbatore for the Academic year 2020-2021
- 8. Based on the request of the Managing Trustee and the approval of the Pharmacy Council of India, New Delhi (PCI), an inspection was conducted on 14.12.2020 by the Inspection Commission constituted for the grant of increase in seats in M.Pharm. Pharm. Analysis branch the commission has inspected & submitted its report. Scrutiny of the inspection report indicates the institution has fulfilled the necessary requirements for the grant increase for the said branch.
- 9. In pursuance of the above, the University grants Continuance of Provisional Affiliation and Increase of seats in M.Pharm. Pharm. Analysis branch to KMCH College of Pharmacy, Coimbatore for conducting M.Pharm. Degree Course for the academic year 2020 - 2021 as indicated below subject to the usual conditions already intimated in the Provisional Affiliation orders of this University.
